



How to access Virtual Court using a Smartphone or Computer

The following steps will assist you in accessing your court date virtually by video, using a smartphone or computer.

1. Prior to your court date, download the Microsoft Teams Application to your smartphone or computer.

3. To join the virtual courtroom, click the link next to your assigned courtroom.
 - a. Alternatively, you can copy and paste the link directly into your internet browser.
4. When you enter the virtual courtroom lobby, your microphone and camera will automatically be off. To turn them on, click the video and microphone icons.
 - a. You will remain muted until asked by court staff. To unmute, dial *6.
5. During the session, you can tap/click the center of your screen at any point to open the toolbar for the following controls:
 - a. Camera
 - b. Microphone
 - c. Volume
 - d. Meeting Chat
 - e. Exit
